Fill out the information on the other side of this form and submit it to CalOptima to receive your no-cost \$25 gift card.

Diabetes Eye Exam Incentive Form

How to qualify for the no-cost member gift card:

1. Call your primary care provider (PCP) to get a referral to see an eye doctor specialist (an ophthalmologist) if you do not have one already. Or you can call your regular eye doctor (an optometrist) to see if you are eligible for a diabetes eye exam.
 - » **Schedule a visit with your eye doctor to get your diabetes eye exam.**
 - » The date of the exam must be between January 1, 2020, and December 31, 2020.
2. Fill out this form. **Make sure your eye doctor stamps this form.**
3. Submit this form to CalOptima by January 31, 2021.
